**Subject: Implementation of BIS Regulations 2018**

1. The Bureau of Indian Standards (Conformity Assessment) Regulations, 2018 have been notified vide F. No. BS/11/11/2018 dated 04<sup>th</sup> June 2018 in Gazette of India. The Gazette is available on BIS and CRS website.
2. CRS portal is in the process of being aligned with the BIS (Conformity Assessment) Regulations, 2018. The details of applicable fee structure for Compulsory Registration Scheme are applicable as per Cl. 5 of Schedule – II of the Regulations.
3. The revised fee structure is as follows:

a. Application Fee

- d. If the renewal application is made after the validity of the licence, the application shall be accompanied by late fee of rupees five thousand.
  - e. After grant of licence, any service requests like change in name/address/management/ Indian representative or e-mail or contact details or model withdrawal in the scope of the licence, updation of critical component of the models in the scope of the licence shall be made on payment of fee of rupees five thousand for each request.
  - f. GST/applicable taxes will be charged on the total amount.
  - g. The above fees as per the per BIS (Conformity Assessment) Regulations, 2018 is applicable with effect from the date of its publication, i.e. 04.06.2018.
4. All the cases applied on or after 04.06.2018 would be processed on receipt of revised fee.
5. This circular is being issued for information to all applicants and registered manufacturers.
